PURPOSE OF POSITION DESCRIPTION

SECTION 2

POSITION SUMMARY

The Purpose of the Position:

The volunteer role provides support to Lung Foundation Australia (LFA) by engaging with policy makers (and government) in the local community to increase investment to improve health outcomes for people living with lung cancer and lung disease more broadly.

Directly reporting to the Advocacy and Policy Manager at LFA, the role is part of a team contributing to the delivery of the Lung Health Advocacy Project (the Project).

The role involves Volunteer Lung Health Advocates (Advocates) to undertake training to increase knowledge, skills and confidence in delivering advocacy activities for LFA. Included in the training, Advocates will be shown how to utilise a toolkit of resources to assist in engagement with local Members of Parliament in local communities. The toolkit will be aligned with key policy documents including:

- National Strategic Action Plan for Lung Conditions (the Action Plan)
- Making Lung Cancer A Fair Fight: A Blueprint for Reform (the Blueprint)

It is from these documents that LFA has developed messaging and key 'Asks' to use in advocacy with Government. The focus of Advocate engagement will be on persuading local Members and Senators to change policy for the better by increasing investment in lung cancer programs, support for people living with lung cancer, and research (including screening).

Reporting on outcomes of the engagement with Members of Parliament will be an important part of the Project. LFA reviews the way it operates through a Continuous Quality Improvement Process. The role will contribute to this process and provide feedback on the delivery of the Project.

As a representative of LFA, Advocates will also be expected to adhere to policies and codes of conduct.

Skills, Qualifications and Attributed required

- A person living with a lung condition/cancer OR a carer/family member of a person with a lung condition/cancer OR a health professional involved in identification, diagnosis and management of a people living with lung conditions OR an academic involved in research into lung conditions.
- An understanding of lung cancer and/or lung conditions that directly impact the lives of the people in the Australian community including barriers to access to evidencebased
- Highly developed interpersonal and written communication skills
- An ability to use Microsoft Office software
- A commitment and personal alignment with Lung Foundation Australia Vision, Purpose and Values
